

Georgetown College Involvement Fair: 8/27/26 Giveaway Promotion Rules

These are the Official Rules for Commonwealth Credit Union's ("CCU") Georgetown College Involvement Fair: 8/27/26 ("Giveaway")

NO PURCHASE OR ACCOUNT OPENING IS NECESSARY TO ENTER OR WIN. MAKING A PURCHASE, OPENING AN ACCOUNT OR OBTAINING A LOAN WITH CCU WILL NOT INCREASE YOUR ODDS OF WINNING. PROMOTION IS VOID WHERE PROHIBITED BY LAW.

- I. Terms and Conditions - By entering the Promotion, you fully and unconditionally agree to abide by and accept these Official Rules. Failure to comply with these Official Rules may result in your disqualification from the Promotion.

You may also enter by filling out a piece of paper with your name and telephone number at our CCU table during event hours. Duplicate entries by text or paper entry will be disqualified. Entries

- must be received during the promotion period. If you wish to be removed from future sweepstakes, please email us at mkting@cwcu.org and we will shred your paper entry form. If you wish to be removed from receiving future text messages please follow the directions on your phone. To be eligible individuals must be 18 years of age or older.
- IV. Prize - The prize winner(s) will be selected by random drawing from all entries received during the Promotion Period on August 28th, 2026 at 9:00 AM (EST) (Paper and Text to Win entries). The winner will be contacted via text message. The prize winner will receive a \$50 Visa gift card. If the winner cannot be contacted using the information provided with the entry, by telephone, or the prize is not claimed by September 4th, 2026 another winner will be drawn. The prize is nontransferable and prize substitution will not be allowed.
 - V. Publicity - Winner agrees to sign a public publicity release for CCU to use your name and likeness for editorial, advertising and publicity purposes without additional compensation, except where prohibited by law. By participating in this Promotion, all entrants' further consent to CCU's use of the personal information provided so that CCU may administer the promotion and award the prize.
