

Millstone Festival 2025: Giveaway Promotion Rules

These are the Official Rules for Commonwealth Credit Union's ("CCU") Millstone Festival 2025 ("Giveaway")

NO PURCHASE OR ACCOUNT OPENING IS NECESSARY TO ENTER OR WIN. MAKING A PURCHASE, OPENING AN ACCOUNT OR OBTAINING A LOAN WITH CCU WILL NOT INCREASE YOUR ODDS OF WINNING. PROMOTION IS VOID WHERE PROHIBITED BY LAW.

- I. Terms and Conditions - By entering the Promotion, you fully and unconditionally agree to abide by and accept these Official Rules. Failure to comply with these Official Rules may result in your disqualification from the Promotion.
- II. Eligibility - The Promotion is open only to legal residents of the United States, who, at the time of entering the Promotion are eighteen years of age or older. By entering, entrants agree to comply with these Official Rules, including all eligibility requirements. Promotion Period - The Promotion begins on October 4th, 2025 at 11:00 AM Eastern Standard Time (EST) and ends October 4th, 2025 at 8:00 PM Eastern Standard Time (EST) (the "Giveaway Period").
- III. How to Enter - No Purchase Necessary to Enter or Win. During the giveaway period, you may enter by texting "MILLSTONE" to (502)465-7812 or by scanning the QR code. You may also enter by filling out a piece of paper with your name and telephone number at our CCU table during event hours. Duplicate entries by text or paper entry will be disqualified. Entries must be received during the promotion period. If you wish to be removed

- from future sweepstakes, please email us at mkting@cwcu.org and we will shred your paper entry form. If you wish to be removed from receiving future text messages please follow the directions on your phone. To be eligible individuals must be 18 years of age or older.
- IV. Prize - The prize winner(s) will be selected by random drawing from all entries received during the Promotion Period on October 6th, 2025 at 9:00 AM (EST) (Paper and Text to Win entries). The winner will be contacted via text message. The prize winner will receive a \$100 Visa gift card. If the winner cannot be contacted using the information provided with the entry, by telephone, or the prize is not claimed by October 14th, 2025 another winner will be drawn. The prize is nontransferable and prize substitution will not be allowed.
 - V. Publicity - Winner agrees to sign a public publicity release for CCU to use your name and likeness for editorial, advertising and publicity purposes without additional compensation, except where prohibited by law. By participating in this Promotion, all entrants' further consent to CCU's use of the personal information provided so that CCU may administer the promotion and award the prize.
