

Sweet Owen Day Festival 2025 Giveaway Promotion Rules

These are the Official Rules for Commonwealth Credit Union's ("CCU") Sweet Owen Day Festival 2025 ("Giveaway")

If you wish to be removed from future sweepstakes, please email us at mkting@cwcu.org and we will shred your paper entry form. If you wish to be removed from receiving future text messages, please follow the directions on your phone. To be eligible individuals must be 18 years of age or older.

- Prize - The prize winner(s) will be selected by random drawing from all entries received during the Promotion Period on September 22nd, 2025 at 9:00 AM (EST) (Paper and Text to Win entries). The winner will be contacted via text message. The prize winner will receive a Sweet Owen Gift Basket. If the winner cannot be contacted using the information provided with the entry, by telephone, or the prize is not claimed by September 29th, 2025 another winner will be drawn. The prize is nontransferable and prize substitution will not be allowed.
- Publicity - Winner agrees to sign a public publicity release for CCU to use your name and likeness for editorial, advertising and publicity purposes without additional compensation, except where prohibited by law.
