

Candlelight Weekend 2025 Giveaway Promotion Rules

These are the Official Rules for Commonwealth Credit Union's ("CCU") Candlelight Weekend 2025 ("Giveaway")

NO PURCHASE OR ACCOUNT OPENING IS NECESSARY TO ENTER OR WIN. MAKING A PURCHASE, OPENING AN ACCOUNT OR OBTAINING A LOAN WITH CCU WILL NOT INCREASE YOUR ODDS OF WINNING. PROMOTION IS VOID WHERE PROHIBITED BY LAW.

- I. Terms and Conditions - By entering the Promotion, you fully and unconditionally agree to abide by and accept these Official Rules. Failure to comply with these Official Rules may result in your disqualification from the Promotion.

You may also enter by filling out a piece of paper with your name and telephone number at our High Street branch during business hours within the promotion period. Entries must be

received during the promotion period. If you wish to be removed from future sweepstakes, please email us at mkting@cwcu.org and we will shred your paper entry form. If you wish to be removed from receiving future text messages please follow the directions on your phone. To be eligible individuals must be 18 years of age or older.

- IV. Prize - The prize winner(s) will be selected by random drawing from all entries received during the Promotion Period on November 12th at 9:00 AM (EST) (Paper and Text to Win entries). The winner will be contacted by the email or phone information that they listed on the entry. The prize winner will receive a \$150 gift card to their selected favorite Downtown Frankfort Restaurant and a \$100 gift card to their selected favorite Downtown Frankfort Store. If the winner cannot be contacted using the information provided with the entry, by telephone, or the prize is not claimed by December 1st, 2025, another winner will be drawn. The prize is nontransferable, and prize substitution will not be allowed.
- V. Publicity - Winner agrees to sign a public publicity release for CCU to use your name and likeness for editorial, advertising and publicity purposes without additional compensation, except where prohibited by law.
