

## Zoeller Event 1/31/23 Giveaway Promotion Rules

The winner will be contacted via text message. The prize winner will receive a \$50 Visa Gift Card. If the winner cannot be contacted using the information provided with the entry, by telephone, or the prize is not claimed by February 7<sup>th</sup>, 2023 another winner will be drawn. The prize is nontransferable and prize substitution will not be allowed.
