

## Commonwealth Credit Union's Wicked Old Forester's Paristown Hall Ticket Giveaway Promotion Rules

These are the Official Rules for Commonwealth Credit Union's ("CCU") Wicked Old Forester's Paristown Hall Ticket Giveaway Promotion. This is a prize-linked promotion where with each entry, participants will earn 1 (one) chance to win two (2) Premium Tickets to an Old Forester's Paristown Hall Concert through a series of four (4) drawings during the promotion period. The promotion period is from September 7, 2023 through October 7, 2023, with the first winner being drawn September 20, 2023 and the last winner being drawn on October 10, 2023. The following official rules apply to all participants, including the Prize winners.

NO PURCHASE OR ACCOUNT OPENING IS NECESSARY TO ENTER OR WIN. MAKING A PURCHASE, OPENING AN ACCOUNT OR OBTAINING A LOAN WITH CCU WILL NOT INCREASE YOUR ODDS OF WINNING. PROMOTION IS VOID WHERE PROHIBITED BY LAW.

1. **Terms and Conditions** - By entering the Promotion, you fully and unconditionally agree to abide by and accept these Official Rules. Failure to comply with these Official Rules may result in your disqualification from the Promotion.
2. **Eligibility** - The Promotion is open only to legal residents of the United States, who, at the time of entering the Promotion, are eighteen years of age or older. All entrants must be natural persons. No entries from business entities accepted. Employees of CCU, its volunteers, affiliates, subsidiaries, advertising or promotional agencies, and their immediate family members and/or those living in same household are not eligible to enter the Promotion. Immediate family includes spouse, parents, siblings, children, stepparents, stepchildren, grandparents, and grandchildren. CCU reserves the right to verify eligibility qualifications of any winner. The value of each prize represents CCU's good faith determination of the maximum retail value thereof. For Form 1099 reporting purposes, each winner shall be bound by such good faith determination. By entering, entrants agree to comply with these Official Rules, including all eligibility requirements. 3. **Promotion Period** - The Promotion begins on September 20, 2023 at 12:00:01 AM Eastern Daylight Time (EDT) and ends October 7th, 2023 at 11:59:59 PM Eastern Daylight Time (EDT) (the "Giveaway Period").
4. **How to Enter** - No Purchase Necessary to Enter or Win. During the giveaway period, you may enter by scanning the QR code printed in the Audience Playbill for the fall performances of Wicked at the Kentucky Center for the Arts. You may also enter by filling out a piece of paper with your name and telephone number and mailing it to Commonwealth Credit Union, Attn: Marketing Department, PO BOX 978, Frankfort, KY 40602 . Duplicate entries will be disqualified. Entries must be received during the promotion period. If you wish to be removed from future sweepstakes, please email us at [mkting@cwcu.org](mailto:mkting@cwcu.org) and we will shred your paper entry form. To be eligible, individuals must be 18 years of age or older.

5. **Prize** - The prize winner(s) will be selected by random drawing from all available entries received during the Promotion Period. The drawings will be held on September 25, 2023, September 29, 2023, October 4, 2023, and October 10, 2023. The winner will be contacted via email or telephone. Each prize winner will receive 2 Premium Tickets to a concert at Old Forester's Paristown Hall. If the winner cannot be contacted using the information provided with the entry, by email or telephone, or the prize is not claimed with 3 business days of being contacted, another winner will be drawn. The prize is nontransferable and prize substitution will not be allowed.
6. **Publicity** - Winner agrees to sign a public publicity release for CCU to use your name and likeness for editorial, advertising and publicity purposes without additional compensation, except where prohibited by law. By participating in this Promotion, all entrants' further consent to CCU's use of the personal information provided so that CCU may administer the promotion and award the prize.
