

Georgetown Golf QR Code Giveaway Promotion Rules

These are the Official Rules for Commonwealth Credit Union's ("CCU") Georgetown Golf QR Code ("Giveaway")

NO PURCHASE OR ACCOUNT OPENING IS NECESSARY TO ENTER OR WIN. MAKING A PURCHASE, OPENING AN ACCOUNT OR OBTAINING A LOAN WITH CCU WILL NOT INCREASE YOUR ODDS OF WINNING. PROMOTION IS VOID WHERE PROHIBITED BY LAW.

- I. Terms and Conditions - By entering the Promotion, you fully and unconditionally agree to abide by and accept these Official Rules. Failure to comply with these Official Rules may result in your disqualification from the Promotion.
- II. Eligibility - The Promotion is open only to legal residents of the United States, who, at the time of entering the Promotion are eighteen years of age or older. - III. How to Enter - No Purchase Necessary to Enter or Win. During the giveaway period, you may enter by scanning the QR code on the Georgetown Golf Sign and filling out a Formstack. Entries must be received during the promotion period. If you wish to be removed from future sweepstakes, please follow the directions on your phone. To be eligible individuals must be 18 years of age or older.

- IV. Prize - The prize winner(s) will be selected by random drawing from all entries received during the Promotion Period monthly, on the third Friday of every month starting April 2023. The winner will be contacted via phone number. The prize winner will receive a golf related prize. If the winner cannot be contacted using the information provided with the entry, by telephone, or the prize is not claimed by the last Friday of the month, another winner will be drawn. The prize is nontransferable and prize substitution will not be allowed.
- V. Publicity - Winner agrees to sign a public publicity release for CCU to use your name and likeness for editorial, advertising and publicity purposes without additional compensation, except where prohibited by law. By participating in this Promotion, all entrants' further consent to CCU's use of the personal information provided so that CCU may administer the promotion and award the prize.
