

Scott County Schools New Teacher Meeting 2025 Giveaway Promotion Rules

These are the Official Rules for Commonwealth Credit Union's ("CCU") Scott County Schools New Teacher Meeting 2025 ("Giveaway")

(Paper and business card entries). The winner(s) will be contacted using the information provided on the entry slip. If the winner(s) cannot be contacted using the information provided with the entry, by telephone, or the prize is not claimed by August 8th, 2025 another winner will be drawn.
