

## Sweet Owen Day 9/21/2024 Giveaway Promotion Rules

These are the Official Rules for Commonwealth Credit Union's ("CCU") Sweet Owen Day 9/21/2024 ("Giveaway")

You may also enter by filling out a piece of paper with your name and telephone number at our CCU table during event hours. Duplicate entries by text or paper entry will be disqualified. - IV. Prize - The prize winner(s) will be selected by random drawing from all entries received during the Promotion Period on September 23<sup>rd</sup>, 2024 at 9:00 AM (EST) (Paper and Text to Win entries). The winner will be contacted via text message. The prize winner will receive a Sweet Owen gift basket. If the winner cannot be contacted using the information provided with the entry, by telephone, or the prize is not claimed by September 30<sup>th</sup>, 2024 another winner will be drawn. The prize is nontransferable and prize substitution will not be allowed.
  - V.
