

Old Forester's Paristown Hall Tickets 2026 Tickets Giveaway Promotion Rules

event hours or through our business partner events and special offers. Duplicate entries by text or paper entry will be disqualified. Entries must be received during the promotion period. If you wish to be removed from future sweepstakes, please email us at mkting@cwcu.org and we will shred your paper entry form. If you wish to be removed from receiving future text messages, please follow the directions on your phone. To be eligible individuals must be 18 years of age or older.

IV. Prize - The prize winner(s) will be selected by random drawing from all entries received during the Promotion Period at least 3 days before the event date. The winner(s) will be contacted via email. The winners will receive either two or four tickets for event that they entered for. If the winner cannot be contacted using the information provided with the entry, by email or telephone, or the prize is not claimed within 24 hours of attempted communication another winner will be drawn. The prize is nontransferable and prize substitution will not be allowed.

V.
