

Teacher of the Year Teacher Appreciation Week 2026 Giveaway Promotion Rules

These are the Official Rules for Commonwealth Credit Union's ("CCU") Teacher of the Year Teacher Appreciation Week 2026 Giveaway ("Giveaway")

To be eligible individuals must be 18 years of age or older.
- IV. Prize - The prize winner(s) will be selected by adjudication in two stages. Finalists will be selected on April 16th, 2026 and must confirm intent to proceed and a personal statement no later than April 22nd, 2026 at 11:59 PM (EST). Winner(s) will be selected through a second adjudication process, ending on April 27th, 2026. Winner(s) will be contacted via email or in person at the winner's school during Teacher Appreciation Week (May 4th – May 8th, 2026). Prize winner(s) will submit a Form W-9 to receive a \$1,000 check via mail,

delivery, or branch pick-up. The prize is nontransferable and prize substitution will not be allowed.

- V. Publicity – By participating in this Promotion, Nominator(s) and Winner(s) agree to sign a public publicity release for CCU to use your name, school name, and likeness for editorial, advertising and publicity purposes without additional compensation, except where prohibited by law.
