

Richmond Grand Opening Giveaway Promotion Rules

These are the Official Rules for Commonwealth Credit Union's ("CCU") Richmond Grand Opening ("Giveaway")

You may also enter by filling out a piece of paper with your name and telephone number at our CCU table during event hours. Duplicate entries by text or paper entry will be disqualified. - from future sweepstakes, please email us at mkting@cwcu.org and we will shred your paper entry form. If you wish to be removed from receiving future text messages, please follow the directions on your phone. To be eligible individuals must be 18 years of age or older.
- IV. Prize - The prize winner(s) will be selected by random drawing from all entries received during the Promotion Period on July 22nd, 2024, 9:00 AM (EST) (Paper and Text to Win entries). The winner will be contacted via text message. The prize winner will receive a YETI® Cooler. If the winner cannot be contacted using the information provided with the entry, by telephone, or the prize is not claimed by July 25th, 2024, another winner will be drawn. The prize is nontransferable and prize substitution will not be allowed.
 - V.
