

Carrier Vibrating Equipment Tabling: 11/14/24 Giveaway Promotion Rules

These are the Official Rules for Commonwealth Credit Union's ("CCU") Carrier Vibrating Equipment Tabling: 11/14/24 ("Giveaway")

If you wish to be removed from receiving future text messages please follow the directions on your phone. To be eligible individuals must be 18 years of age or older.
- IV. Prize - The prize winner(s) will be selected by random drawing from all entries received during the Promotion Period on November 15th, 2024 at 9:00 AM (EST) (Paper and Text to Win entries). The winner will be contacted via text message. The prize winner will receive a \$50 Visa gift card. If the winner cannot be contacted using the information provided with the entry, by telephone, or the prize is not claimed by November 22nd, 2024 another winner will be drawn. The prize is nontransferable and prize substitution will not be allowed.
 - V.
