

St.Matthew's Festival VIP Tickets 2025 Giveaway Promotion Rules

These are the Official Rules for Commonwealth Credit Union's ("CCU") Casting for Kids ("Giveaway")

If you wish to be removed from receiving future text messages please follow the directions on your phone. To be eligible individuals must be 18 years of age or older.

- Prize - The prize winner(s) will be selected by random drawing from all entries received during the Promotion Period on June 18th, 2025 at 12:00 PM (EST) (Paper and Text to Win entries). The winner will be contacted via email. The prize winner will receive 6 St. Matthew's festival VIP tickets and a \$100 food voucher. If the winner cannot be contacted using the information provided with the entry, by telephone, or the prize is not claimed by June 19th, 2025 another winner will be drawn. The prize is nontransferable and prize substitution will not be allowed.
