

## Luther Lockett Correctional Institution Tabling 6/1/23 Giveaway Promotion Rules

These are the Official Rules for Commonwealth Credit Union's ("CCU") Luther Lockett Correctional Institution Tabling 6/1/23 ("Giveaway")

The prize is nontransferable and prize substitution will not be allowed.
