

KASS Conference: December 2025 Giveaway Promotion Rules

These are the Official Rules for Commonwealth Credit Union's ("CCU") KASS Conference: December 2025 ("Giveaway")

Duplicate entries will be disqualified. Entries must be received during the promotion period. If you wish to be removed from future

- IV. Prize - The prize winner(s) will be selected by random drawing from all entries received during the Promotion Period on December 8th, 2025, at 4:00 PM. (Paper and business card entries). The prize winner(s) will receive a Kentucky gift basket. Winner must be present to claim prize, if the first winner is not available then another winner will be drawn. The prize is nontransferable, and prize substitution will not be allowed.
- V. Publicity - Winner agrees to sign a public publicity release for CCU to use your name and likeness for editorial, advertising and publicity purposes without additional compensation, except where prohibited by law.
