

## Lexington Home & Garden Show: April 5<sup>th</sup>-7<sup>th</sup>, 2024 Giveaway Promotion Rules

These are the Official Rules for Commonwealth Credit Union's ("CCU") Lexington Home & Garden Show: April 5<sup>th</sup> – 7<sup>th</sup>, 2024 ("Giveaway")

If you wish to be removed from receiving future text messages please follow the directions on your phone. To be eligible individuals must be 18 years of age or older.

The winner will be contacted via text message. The prize winner will receive a Yeti Cooler. If the winner cannot be contacted using the information provided with the entry, by telephone, or the prize is not claimed by April 15<sup>th</sup>, 2024 another winner will be drawn. The prize is nontransferable and prize substitution will not be allowed.
