

Owen County Teachers Benefits Fair 2025 Giveaway Promotion Rules

These are the Official Rules for Commonwealth Credit Union's ("CCU") Owen County Teachers Benefits Fair 2025 ("Giveaway")

we will shred your paper entry form. If you wish to be removed from receiving future text messages please follow the directions on your phone. To be eligible individuals must be 18 years of age or older.

(Paper and business card entries). The winner(s) will be contacted using the information provided on the entry slip. The prize winner(s) will receive a \$50 Visa Gift Card. If the winner cannot be contacted using the information provided with the entry, by telephone, or the prize is not claimed by August 13th, 2025 another winner will be drawn. The prize is nontransferable and prize substitution will not be allowed.
- V.
