

Small Business Week 2024 Giveaway Promotion Rules

These are the Official Rules for Commonwealth Credit Union's ("CCU") Small Business Week 2024 ("Giveaway")

messages please follow the directions on your phone. To be eligible individuals must be 18 years of age or older.

- IV. Prize - The prize winner(s) will be selected by random drawing from all entries received during the Promotion Period on at 9:00 AM (EST) daily starting April 29th through May 3rd. The winner(s) will be contacted via email or phone. The prize winner(s) will receive a special food/treat courtesy of Commonwealth Credit Union. If the winner cannot be contacted using the information provided with the entry, by telephone, or the prize is not claimed on the same day of contact, another winner will be drawn. The prize is nontransferable and prize substitution will not be allowed.
- V. Publicity - Winner agrees to sign a public publicity release for CCU to use your name and likeness for editorial, advertising and publicity purposes without additional compensation, except where prohibited by law. By participating in this Promotion, all entrants' further consent to CCU's use of the personal information provided so that CCU may administer the promotion and award the prize.
