If you wish to be removed from receiving future text messages please follow the directions on your phone. To be eligible individuals must be 18 years of age or older.

The winner will be contacted via text message. The prize winner will receive a Yeti Cooler. The prize is nontransferable and prize substitution will not be allowed.
- V.
