

## Jack Harlow Concert Tickets Giveaway

These are the Official Rules for Commonwealth Credit Union's ("CCU") Jack Harlow Concert Tickets ("Giveaway")

If you wish to be removed from receiving future text messages please follow the directions on your phone. To be eligible individuals must be 18 years of age or older.

Two winners, two (2) sets of tickets each to the Jack Harlow Concert on Saturday, December 18<sup>th</sup> at Paristown Hall in Louisville. Valued at \$40.50 a ticket. If the winners cannot be contacted using the information provided with the entry, by telephone, or the prize is not claimed by December 17<sup>th</sup>, 2021 at 5pm another winner will be drawn. The prize is nontransferable and prize substitution will not be allowed.
- V.
